

Frequently Asked Questions

▶ What is the course schedule?

Lectures are held on two evenings per week. In the first year, the lecturers are normally on Tuesdays and Thursdays from 6.30 to 9.00 pm. There will also be a requirement to attend one on-campus day at the end of each semester.

Orientation and lectures always take place on Friday and Saturday within the last two weeks of January from 9 am-5 pm.. The official dates can be found on the course page under "Delivery".

▶ Are videos of lectures available to students?

Videos of the lecture are available following the lecture.
IMPORTANT: Students are advised to attend the lectures.

▶ What is the fee?

The fees for 2025 are not confirmed. Please reach out to the team for more information. Payments are made on a yearly basis.

▶ Are instalment payments available?

We offer payment plans starting three months prior to the course commencement. However, all fees must be settled in full before the course begins.

▶ What is the duration of the programme?

Semester 1 - Jan - May 2025
Semester 2 - Sep - Dec 2025
Semester 3 - Jan - May 2026
Dissertation - May 2025 - Sep/Dec/ 2026. (dependent on the student)

▶ What is the final award?

The final award is a Level 9 NFQ qualification, equivalent to 90 ECTS credits.

▶ When are the written exams scheduled?

Exams are held in May and January

▶ Are there breaks during the duration of the programme?

If the semester schedule allows there is sometimes a reading week off in the middle of the semester.

MSc in Software Solutions Architecture Frequently Asked Questions

▶ **Are there group projects or is it all individual-based assessments?**

Assignments are a mixture of both group and individual projects. Specifically, while some projects are completed within groups and entail technical aspects, all technical projects are completed individually.

▶ **Is there tax relief if so, can you claim back any tax?**

You may apply for a tax relief however it is the responsibility of each applicant to contact the tax office regarding this. We can provide a receipt for fees paid if needed.

▶ **For applicants, whose first language is not English are they required to provide evidence of English language proficiency?**

Yes, there is a requirement to complete an English Language test for applicants, whose first language is not English. Please follow the link for further information.
